1. Tests T.1 to T.5 shall be conducted in sequence on the same cell. Tests T.6 and T.8 shall be conducted using not otherwise tested cells.

2. In order to quantify the mass loss, the following procedure is provided:

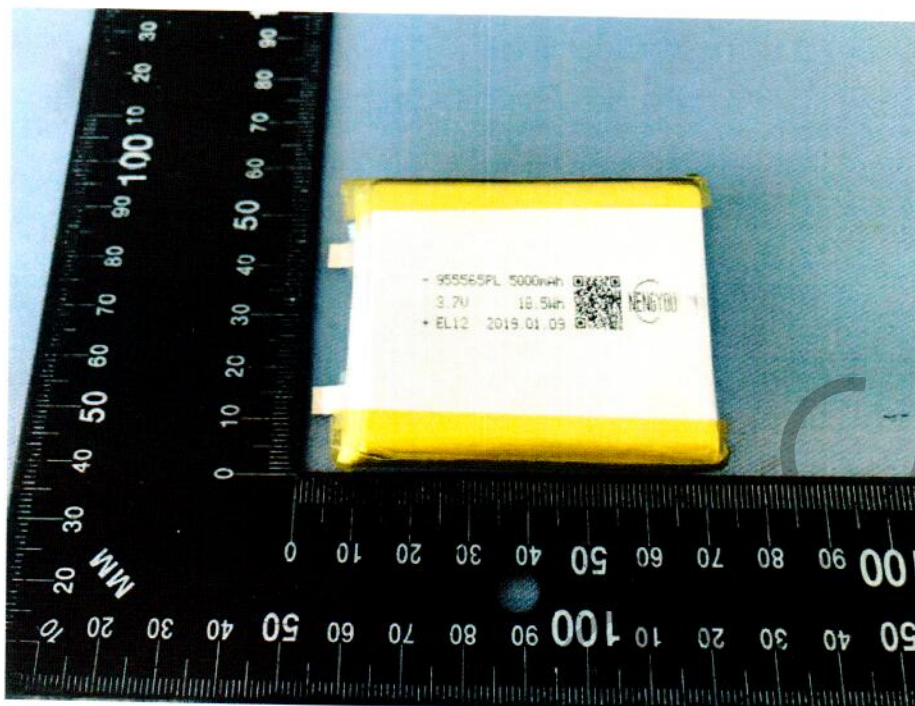


Figure 1 Overall view I of cell

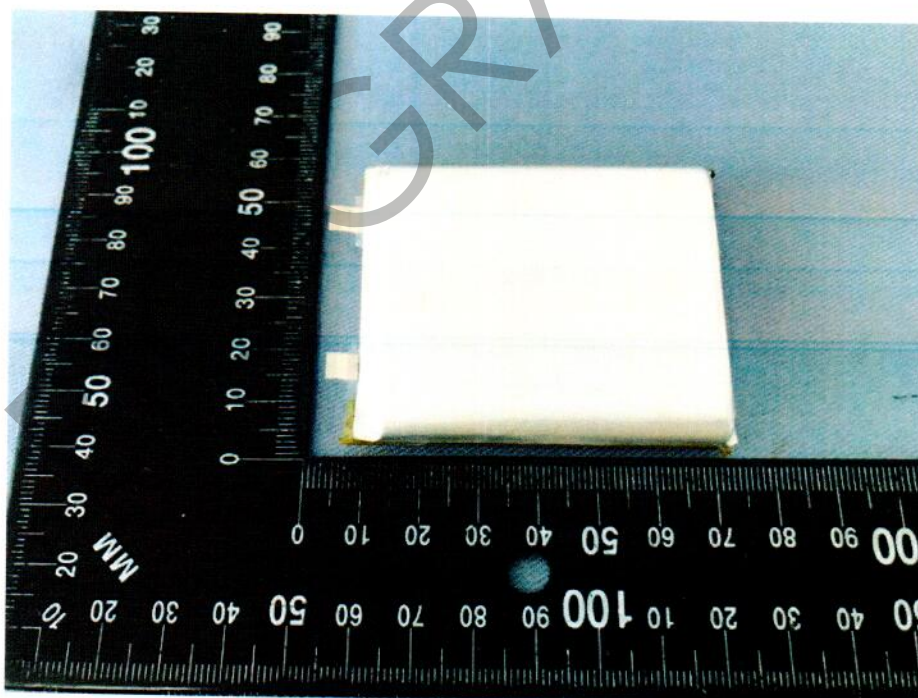


Figure 2 Overall view II of cell
